**MAGISTRATE'S ORDER FOR EMERGENCY PROTECTION**

On This The 24th Day Of April, 2012 Sanders, Pilar Michelle appeared before the undersigned magistrate after arrest for an offense involving family violence under Section 22.01, Penal Code.

After a post-arrest hearing as provided by law, the Court considered entering an order for emergency protection by motion of the OFFICER, and after considering the evidence, the Court enters an order intended to protect the victim(s), DEION SANDERS B/M DOB [REDACTED]

**IT IS HEREBY ORDERED** that effective immediately and for the next 61 days from the issuance of this Order Sanders, Pilar Michelle whose relationship to the protected person (s) is **SPOUSE**

is prohibited from:

- Committing family violence, an assault on a person protected under this Order, or an act in furtherance of an offense under Sec. 42.072, Penal Code as these terms are defined herein;
  
- Communicating directly with a member of the family or household or with the person protected under this Order in a threatening or harassing manner; or communicating a threat through any person to a member of the family or household or to the persons protected under this Order; and
  
- Going within 100 Yards of all properties listed in the order and:

**IT IS FURTHER ORDERED** that Sanders, Pilar Michelle may send a designated representative, to 1280 N. PRESTON RD. PROSPER, TX. 75078 Collin County, Texas, for the purpose of removing personal belongings. This may be done only once, with-in 24 hours of the release from jail between the hours of 1:00 pm and 6:00 pm and only if approved by the victim.

**WARNING**

**“A VIOLATION OF THIS ORDER BY COMMISSION OF AN ACT PROHIBITED BY THE ORDER MAY BE PUNISHABLE BY A FINE OF AS MUCH AS \$4000.00 OR BY CONFINEMENT OF JAIL FOR AS LONG AS ONE YEAR OR BY BOTH. AN ACT THAT RESULTS IN FAMILY VIOLENCE OR A STALKING OFFENSE MAY BE PROSECUTED AS A SEPARATE MISDEMEANOR OR FELONY OFFENSE. IF THE ACT IS PROSECUTED AS A SEPARATE FELONY OFFENSE, IT IS PUNISHABLE BY CONFINEMENT IN PRISON FOR AT LEAST TWO YEARS.**

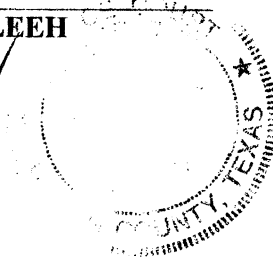

**NO PERSON, INCLUDING A PERSON WHO IS PROTECTED BY THIS ORDER, MAY GIVE PERMISSION TO ANYONE TO IGNORE OR VIOLATE ANY PROVISION OF THIS ORDER. DURING THE TIME IN WHICH THIS ORDER IS VALID, EVERY PROVISION OF THIS ORDER IS IN FULL FORCE AND EFFECT UNLESS A COURT CHANGES THE ORDER.”**

**IT IS FURTHER ORDERED** that this Order shall remain in effect through the 61<sup>st</sup> day after the date of issuance.
